# 3. Family Engagement

#### Family Survey Update:

Miriam Jacobs, Family Engagement Manager, met with Joni Sprague, Educare's Family Services Supervisor and Parent Ambassador staff, and parents to plan for the upcoming parent survey. There was good discussion around parent engagement, the way the survey is written/completed and the need to explain why the survey is conducted in an effort to increase the return rate.

# Miriam shared upcoming event dates:

- Head Start Goes to Augusta will be held both in-person and via Zoom (two different dates). Parents are encouraged to attend to show their support for Head Start. March 29: 3-hour zoom; May 13: in-person at the State House.
- KVCAP Child & Family Services 2<sup>nd</sup> Annual Recruitment Day will take place on May 20<sup>th</sup>. This is a great opportunity for parents to help spread the word to support child enrollment. Watch for information on how to be involved in your communities!
- March 29<sup>th</sup>, from 1:00–3:00 PM, Policy Council Officers are invited to join a Child & Family Services Directors meeting to review the current landscape, projected budget for the upcoming program year and discuss what key changes, if any, should be proposed. # Michael Mosley shared Maine Parent Advisory Network (MPAN):

 Maine Children's Alliance received two grants to expand parent advocacy leading policy conversations. One is specifically focused on early childhood special education. A survey was created to research what topics would be included in the MPAN meetings. The survey link is <u>https://forms.gle/t77MtBy2wyDgaJ176</u>. Tracye Fortin indicated further conversation would be beneficial to consider how MPAN and Parent Ambassadors intersect.

# 4. <u>Reports:</u>

- KVCAP Board Update: Tracye Fortin shared the following updates:
  - The KVCAP financial audit was recently conducted and it was an excellent audit with no findings.
  - Jon Moody, the MSAD #54 Superintendent, presented a draft birth-grade 5 proposal for the new elementary school to the KVCAP Executive Committee. This would be Maine's first new elementary school build that incorporates infants and toddlers. KVCAP Head Start staff the current early care and education programming and the new school allows for expansion and incorporating infants and toddlers within the same building. Educare has been a strong influence. The KVCAP Board approved a fundraising campaign feasibility study to support a portion of this new build.

# • Child & Family Services Chief Operating Officer Report:

- Community Assessment: The KVCAP Community Assessment was conducted for Maine Community Action Program's by a third-party agency. Top needs include housing, childcare and transportation services. Local changes to date include MSAD #49 planning for new school construction. Head Start eligibility remains a challenge with the low income threshold and Maine's minimum wage.
- Self-Assessments: As part of the federal continuation grant application package process, a program conducts Self-Assessments. The draft grant packages will be presented at the April Policy Council meeting. It is important that Policy Council reviews key summaries and discusses program direction, considering data that has been highlighted during the year. An additional opportunity for Policy Council Officers is planned for March 29, 1-3 PM at Educare to review the current landscape, projected budget for the upcoming program year and discuss any key changes proposed.
- Head Start Federal Monitoring Review: The Regional Office provided an update that KVCAP Child & Family Services is not on the list for the 2021-2022 program year. We do anticipate a review next program year.
- COVID Impacts: The Interim Final Rule remains the same. Masks will continue to be required in Head Start facilities for staff, visitors, and children over the age of two. There was discussion about a parent's choice as it relates to masking. Tracye reminded everyone that childcare licensing now follows the CDC guidelines and the agency has moved to 'optional' for staff. Our Head Start program continues to monitor information as we consider the progress toward mask optional. - **Program Information Report Summary:** Reviewed key data: enrollment and eligibility, attendance, and budget. We have been under-enrolled during the pandemic, and again, the Head Start eligibility challenge due to income poverty guidelines is a continued concern.

# 5. Policy Council Meetings

- Virtual/In-person: David Hall asked the Council if they would like to consider options for meeting in person. - **Policy Council Agenda Items:** Mary-Gene reminded Policy Council members that items can always be added to an upcoming agenda, keeping in mind the governance role of the Policy Council; a part of the leadership structure and helps to create/make decisions about governance-related topics within the program. Some topics may be steered to Parent Center Committees, Sub-Committees, etc. or may initiate inviting a speaker for further information about a topic.
