This required permission to serve by the Head Start agency in that county as well as a Change in Scope authorization by our Head Start Regional Office received.

  - o The theme of the Office of Head Start direction is Work Force Crisis; pay teachers more in order to hire and keep staff.
  - Child Health & Safety incidents are increasing with children demonstrating increased behaviors and newer staff with less experience. Reporting requirements have tightened, both in Head Start and in state Child Care Licensing.
