6. Family Engagement

- a. Head Start Goes to Capitol Park debrief/sharing: Shared slide show with photos taken during the day. There were vendors, snacks, tours, and lots of staff and family representation. There was a great turnout overall. It was a great day of community building and learning!
- b. Parent Powered data sharing: Miram shared data from the Parent Powered site. There are 373 active enrollments; 22,099 curricular messages sent; 1762 custom messages sent. Four languages are automatically translated: English, Spanish, Arabic and Chinese. 95% read messages; 100% said they felt supported by texts; 77% said texts helped children learn and grow. This continues to be a well-received app with beneficial data analysis.

- d. Website visibility: Looked at bios currently posted on the website. If anyone needs a head shot taken at Elm City Photo to add to their bio, please let us know.

7. Head Start Director Updates

- a. Reports/Updates
 - i. Program Information Summary: we remain fully enrolled, with enrollment also picking up for the fall. Reviewed dental services and the positive impacts of the dental clinics for children and families. Budget remains on track to be fully spent.
 - ii. Credit Card Expenditures: reviewed together. Recognition that out-of-state lodging can be at high rates when staff travel to conferences in bigger cities.
- b. Focus Area 1 (FA1) update: Area of concern that noted follow up with our regional office (not a high level concern or deficiency) in the area of dental services. We have a strong connection with Waterville Community Dental and will continue to assess any other areas we can improve upon.
- c. Program, Local, State, and National landscape updates: state funding for Head Start was restored, expect flat funding federally.
- d. Eligibility, Recruitment, Selection, Enrollment, Attendance (ERSEA) Policy: reviewed new changes/updated draft.
